

**THE FOLLOWING CHECKLIST INDICATES WHAT IS
NEEDED TO SUBSTITUTE TEACH IN THE
ALLEN COUNTY SCHOOLS
FOR THE 2010-2011 SCHOOL YEAR**

_____ **APPLICATION**

Which can be used for both substitute teaching and fulltime. You can visit our website to download an application at www.allencountyesc.org

_____ **COPY OF CURRENT TEACHING CERTIFICATE/EDUCATIONAL AIDE PERMIT**

Teachers only: Copy of your certificate/license or application for substitute license (requires official transcripts showing bachelor's degree and check payable to Treasurer, State of Ohio – 1 year substitute license \$25, 5-year substitute license \$125). **Aides only:** Copy of your Educational Aide permit or an application and check for \$25 payable to Treasurer, State of Ohio. You can obtain an application by downloading the ODE website at www.ode.state.oh.us and typing in substitute license in the search box.

_____ **IMMIGRATION & NATURALIZATION FORM**

To prove citizenship. We need to have a copy of your driver's license and social security card with this form.

_____ **BCI&I REPORT**

We are required by Ohio law to have a Bureau of Criminal Identification & Investigation report on file for both BCI&I & FBI. Because of the revision of HB1 (Ohio Revised Code 3319.291) regarding FBI/BCI background checks; BCI/FBI background checks are required if you do not have a copy of your report that is less than five (5) years old. We have the National WebCheck® program, which gives us the opportunity to do the fingerprinting here in our office. **The cost is \$25.00 for the BCI&I report and \$35.00 for the FBI report. We accept cash, money order or certified bank check and you must have your driver's license with you.**

_____ **PROOF OF RESIDENCY**

We reserve the right to require proof of residency. Failure to do so may prohibit employment.

_____ **HOMELAND SECURITY (TERRORISM FORM)**

A law was passed (effective 7/1/2006) stipulating that individuals under consideration for school employment must complete this form to declare they are not a terrorist.

_____ **TB TEST**

In August, 2008, Ohio Administrative Code 3701-05-04 (which required tuberculin skin testing) was rescinded effective September 1, 2008. However, the Allen County Health Department developed a TB questionnaire to be completed by any new school employee or substitute teacher and this survey was adopted by the Allen County Schools. Dependent upon the results of the TB survey, you may be required to have a tuberculin skin test to be considered for employment.

_____ **CONFIDENTIALITY AGREEMENT**

Due to FERPA (Family Educational Rights and Privacy Act), students are not to be discussed outside of the classroom with anyone but the classroom teacher and/or teaching assistant. By subbing in any of our local schools, I agree to maintain this student confidentiality at all times.
